I filed for personal bankruptcy. What choice did I have? And I was treated like some sort of low life loser by my attorney.

I attended the University of Richmond and when I passed the bar in 1991 we were \$100,000 in debt. No assets and I didn't have a job. But Gayle and I had a vision of a different kind of law firm.
